The Louis Riel School Division will charge fees for pupils who are not eligible for provincial funding. Therefore, pupils beginning in school after September 30<sup>th</sup> will be assessed fees on a prorated basis.

### **Eligible**

Louis Riel School Division will accept for enrolment, the minor children residing within our School Division boundaries whose parents or legal guardians are in Canada under the Immigration, Refugees and Citizenship Canada (IRCC) authorities listed below:

- **Work Permits** (must include a letter with information stating the employer's name, address, and contact number).
- **Study Permits** (must include a letter with information stating the Designated Learning Institute's name, address, and contact number). NOTE: EAL courses only do not qualify.
- **Temporary Resident Permits** with an accompanying Work Permit (must include a letter with information stating the employer's name, address, and contact number).
- **Temporary Resident Permits** with an accompanying Study Permit (must include a letter with information stating the Designated Learning Institute's name and program which must be vocational or academic, address, and contact number). NOTE: EAL courses only do not qualify.
- **Visiting Forces Act**
- **Refugee Determination Process** (Child refugee claimants do not require parental accompaniment to be supportable).

Note: Students 18 years of age or older whose parents or legal guardians are in Canada under the IRCC authorities listed above would be eligible if they meet the following conditions:

- They have been attending school in Manitoba and the student has been eligible for provincial funding prior to becoming 18 years of age.
- The student is working towards completion of a High School Diploma.

### **Not Eligible**

The following students are not eligible to enrol and will not be accepted unless they are registered by the Louis Riel School Division International Student Program and have paid the required fees:

- Children of parents in Canada as visitors or on a **Temporary Resident Permit** as visitors.
- Children unaccompanied by parents without a court-appointed legal guardianship arrangement that will meet the residency requirements under *The Public Schools Act* with the exemption of refugee claimants.

- Foreign pupils 18 years of age and older if they are attending a Manitoba school for the first time or had attended school in Manitoba but were not eligible for provincial funding.
- Foreign pupils attending school in Manitoba under a foreign exchange arrangement.
